Roll Call: Meeting called to order by Chairman Hames at 7:00 PM

Meeting called to order at 7:00 PM by Chairman Hames

Also present Paul Perry, Gerald Vettel, Morgan Hanson, Clint Miller, Alice Duchanick Meyer, and Abraham Algadi

Minutes of December 13th 2011. Motion by Roy second by Harlan approved 5-0-0

Chairman Hames: Opened the meeting by asking if there are any suggested changes based on input from open house? Schutz said that we have set up the park dedication requirements after we researched other communities and for now we should not change the requirement for park dedication.

Ken Hames, said that John Anderson did review other communities park dedication requirements in the area and the standards for Pine Island are reasonable based on area research. They could always be changed in the future as we see fit.

Staff informed the Commission that the public hearing for adoption of Chapter 12 is scheduled for 7:00 PM on February 14th. The Council will act on Chapter 12 adoption on the 21st of February.

Chairman Hames opened discussion on Michael Jurrens request to allow for chicken raising within residential areas. Staff shared the fact that raising chicken is not prohibited within City limits. The existing Agricultural zoning within the City does allow such use. The main concern with allowing such land use within residential areas is that it will create land use conflicts. Furthermore, staff added that the City would be required to enforce the new code at a cost that could not be covered by the expected revenues from licensing such activity.

Commissioner Friese stated that the City currently has requirements for licensing of cats and dogs. He asked how many licenses are issued now for cats and dogs within the City? Staff responded by saying anywhere from 75 – 80 licenses are issued every year out of a total of at least 2000 cats and dogs.

Following discussion on the advantages and disadvantages of allowing chicken within residential areas, Commissioner Friese made a motion directing staff not proceed further with request to permit chicken raising in residentially zoned districts. Second by Harlan, motion carried.

There being no more business to come before the Commission, meeting adjourned at 7:30 PM

ORDINANCE NO. ~~115~~ 115 (SECOND SERIES)

AN ORDINANCE GRANTING A FRANCHISE TO PINE ISLAND TELEPHONE COMPANY TO CONSTRUCT, OPERATE, AND MAINTAIN A CABLE SYSTEM IN THE CITY OF PINE ISLAND, MINNESOTA; SETTING FORTH CONDITIONS ACCOMPANYING THE GRANT OF THE FRANCHISE; REGULATING OPERATION AND USE OF THE SYSTEM AND PUBLIC RIGHTS-OF-WAY, AND; PRESCRIBING PENALTIES FOR VIOLATIONS OF ITS PROVISIONS

The City of Pine Island (“City”) ordains:

STATEMENT OF INTENT AND PURPOSE

The City intends, by the adoption of this Franchise, to bring about the continued operation and further development of a Cable System. Such a development can contribute significantly to the communication needs and desires of residents of the City. Further, the City may achieve better utilization and improvement of public services with the development and operation of the Cable System. Adoption of this Franchise is, in the judgment of the Council, in the best interests of the City, its residents, and the community.

FINDINGS

The City makes the following findings:

1. Pine Island Telephone Company (“Grantee”) requested renewal of its franchise on or about October 17, 2011, and;
2. Grantee’s prior cable franchise, Ordinance No. 26 Second Series, expired on or about September 18, 2011, and;
3. This Franchise complies with the existing applicable Minnesota Statutes, federal laws and regulations.

SECTION 1.

SHORT TITLE AND DEFINITIONS

1. Short Title. This Franchise Ordinance shall be known and cited as the Cable Communications Ordinance.
2. Definitions. For the purposes of this Franchise, the following terms, phrases, words, and their derivations shall have the meaning given herein. When not inconsistent with the context, words in the singular number include the plural number. The words “shall” or “must” are always mandatory and not merely directory. The word “may” is directory and discretionary and not mandatory.

- a. “Basic Cable Service” means any service tier which includes the lawful retransmission of local television broadcast signals and any public, educational, and governmental access programming required by the Franchise to be carried on the basic tier. Basic Cable Service as defined herein shall not be inconsistent with 47 U.S.C. § 543(b)(7) (1993).
- b. “Cable Service” or “Service” means the provision of television reception, communications and/or entertainment services regulated pursuant to Minn. Stat. § 238.01 et seq. as may be amended from time to time, or as otherwise provided by this Franchise, and distributing the same over a Cable System.
- c. “Cable System” or “System” means a system of antennas, cables, wires, lines, towers, waveguides, or other conductors, converters, equipment, or facilities located in the City and designed and constructed for the purpose of producing, receiving, transmitting, amplifying, or distributing audio, video, and other forms of electronic signals in the City. System as defined herein is consistent with the definition set forth in Minn. Stat. § 238.02, subd. 3.
- d. “City” means the City of Pine Island, Minnesota, acting by and through its City Council.
- e. “Drop” means the cable that connects the ground block on the Subscriber’s residence to the nearest feeder cable of the System.
- f. “FCC” means the Federal Communications Commission and any legally appointed, designated or elected agent or successor.
- g. “Franchise” means this ordinance and the regulatory and contractual relationship established hereby.
- h. “Franchise Fee” means a fee or assessment imposed by the City on a Grantee solely because of its status as a recipient of a Cable Franchise. The term “Franchise Fee” does not include: (i) any tax, fee or assessment of general applicability; (ii) any payments which are required by this Franchise for, or in support of the use of, public, educational, or governmental access facilities; (iii) requirements or charges incidental to awarding or enforcing this Franchise, including payments for bonds, security funds or letters of credit, insurance, indemnification, penalties or liquidated damages; (v) any fee imposed under Title 17 of the United States Code.
- i. “Grantee” is Pine Island Telephone Company, its agents and employees, and lawful successors, transferees or assignees.

- j. “Gross Revenues” means all revenue received by the Grantee from the operation of its System to provide Cable Service in the City.
- k. “Installation” means the connection of the System from feeder cable to the point of connection, including any standard installation and any custom installation.
- l. “Person” is any person, firm, partnership, association, corporation, company, or other legal entity.
- m. “Right-of-Way” or “Rights-of-Way” means the area on, below, or above any real property in the City in which City has an interest including, but not limited to any street, road, highway, alley, sidewalk, parkway, park, skyway, or any other place, area, or real property owned by or under the control of the City, including any other Rights-of-Way dedicated for travel purposes and utility easements.
- n. “Right-of-Way Ordinance” means any ordinance adopted by the City creating requirements regarding regulation, permitting, management and use of Rights-of-Way.
- ~~o. “Standard Installation” means any Installation which can be completed using a Drop of 150 feet or less.~~
- o. ~~p.~~ “Subscriber” means any Person who lawfully receives Service via the System.

SECTION 2.

GRANT OF AUTHORITY AND GENERAL PROVISIONS

1. Franchise Required. It shall be unlawful for any Person to construct, operate or maintain a Cable System or provide Cable Service in City unless such Person shall first obtain and hold a valid franchise.
2. Grant of Franchise. This Franchise is granted pursuant to the terms and conditions contained herein. At the time of acceptance of this Franchise, Grantee shall reimburse the City for all reasonable costs and fees incurred in processing and awarding this franchise. The Grantee may treat such reimbursement as a franchise fee to the extent permitted by applicable law.
3. Grant of Nonexclusive Authority.
 - a. The Grantee shall have the right and privilege pursuant to this Franchise, subject to the requirements of any applicable ordinance, rule or procedure, to construct, erect, operate and maintain a Cable System in, upon, along, across, above, over and under the Rights-of-Way in the City and shall have the right

and privilege to provide Cable Service. The System constructed and maintained by Grantee shall not interfere with other uses of the Rights-of-Way. Grantee shall make use of existing poles and other above and below-ground facilities available to Grantee to the extent it is technically and economically feasible to do so.

- b. Notwithstanding the above grant to use Rights-of-Way, use of such Rights-of-Way shall not be inconsistent with the terms and conditions by which they were created or dedicated, with the present use thereof, and with all legal requirements related to the use thereof including the terms and conditions of any applicable Right-of-Way Ordinance.
 - c. This Franchise shall be nonexclusive and City reserves the right to grant similar use to any Person at any time during the term of this Franchise.
 - d. The City may require all developers of future subdivisions to allow and accommodate the construction of the System as part of any provisions for utilities to serve such subdivisions.
5. Franchise Term. This Franchise shall be in effect for a period of ~~ten~~fifteen (~~10~~15) years from the date of acceptance by Grantee, unless sooner renewed, revoked, or terminated as provided herein.
 6. Previous Franchises. This Franchise supersedes and replaces expired Ordinance No. 26 Second Series.
 7. Compliance with Applicable Laws, Resolutions and Ordinances. The Grantee shall at all times during the term of this Franchise be subject to all lawful exercise of the police power, statutory rights, local ordinance-making authority, and eminent domain rights of the City. This Franchise shall comply with Minnesota franchise standards contained in Minn. Stat. § 238.01 et seq.
 8. Territorial Area Involved/Service Extension.
 - a. This Franchise is granted for the corporate boundaries of the City, as it exists from time to time. Grantee shall be required to extend Service without charge to any requesting Person or area within the City in which Service is requested, ~~provided that such area is within Grantee's authorized telephone service area.~~
 - b. Grantee shall construct and activate plant to provide Service within a reasonable time.
 - c. Access to Service shall not be denied to any group of potential residential cable Subscribers because of the income of the residents of the area in which such group resides.

9. Written Notice. All notices, reports, or demands required to be given in writing under this Franchise shall be deemed to be given when delivered personally to any officer of Grantee or City's Administrator of this Franchise or forty-eight (48) hours after it is deposited in the United States mail in a sealed envelope, with registered or certified mail postage prepaid thereon, addressed to the party to whom notice is being given, as follows:

Such addresses may be changed by either party upon notice to the other party given as provided in this Section.

10. Cable Service to Public Buildings. Grantee shall provide without charge, Installation of one (1) cable Drop, one (1) cable outlet, and monthly Basic Cable Service without charge to the City Hall, City Public Works Department, Pine Island schools (including any relocated facilities), Fire Hall, ~~Library~~, and the ~~Pine Haven nursing home~~City garage. Within ~~six (6) months~~a reasonable time of a written request by City, the Drop at City Hall shall be two-way activated permitting cablecasting of live or recorded programming from such location. No redistribution of the free Service provided pursuant to this Section shall be allowed without the Grantee's prior written consent.

SECTION 3.

CONSTRUCTION STANDARDS

1. Construction Codes and Permits.
- a. Grantee shall obtain all lawful and necessary permits from City before commencing any construction or extension of System, including the opening or disturbance of any Right-of-Way, or private or public property within City. Grantee shall comply with all state and local laws and building and zoning codes currently or hereafter applicable to location, construction, installation, operation or maintenance of the System in the City and give due consideration at all times to the aesthetics of the property.
- b. Consistent with its ROW ordinance, the City shall have the right to inspect all construction or installation work performed pursuant to the provisions of the

Franchise and to make such tests as it shall find necessary to ensure compliance with the terms of the Franchise and applicable provisions of local, state and federal law.

2. Repair of Rights-of-Way and Property. Any and all Rights-of-Way or public or private property, which are disturbed or damaged during the construction, repair, replacement, relocation, operation, maintenance or reconstruction of the System shall be promptly and fully restored by Grantee, at its expense, in accordance with the ROW Ordinance and, in any case, to the same condition as that prevailing prior to Grantee's work, as approved by City in the case of Rights-of-Way and other public property. If Grantee fails to promptly perform the restoration required herein after 30 days' notice from City, City may perform the restoration of the Rights-of-Way, public, or private property as required herein at Grantee's expense.
3. Conditions on Right-of-Way Use.
 - a. Nothing in this Franchise shall be construed to prevent City from adopting and enforcing requirements for the usage of Rights-of-Way or from constructing, maintaining, repairing or relocating sewers; grading, paving, maintaining, repairing, relocating and/or altering any Right-of-Way; constructing, laying down, repairing, maintaining or relocating any water mains; or constructing, maintaining, relocating, or repairing any sidewalk or other public work.
 - b. Upon the City's written request the Grantee shall provide a complete set of ~~strand~~facility maps showing the routing of the Cable System plant and facilities in the Streets, but excluding detail on proprietary electronics or other proprietary information that is related to Grantee's specific design of the Cable System contained therein and Subscriber Drops. The maps ~~shall~~may be provided in an electronic format acceptable to the City. Upon written request, Grantee shall also provide ~~strand map updates~~facility map updates. All such maps and data given to the City shall be considered to be trade secret and not used for any competitive purposes. All System transmission and distribution structures, lines and equipment erected by the Grantee shall be located so as not to obstruct or interfere with the use of Right-of-Way and to cause minimum interference with the rights of property owners who abut any of said Right-of-Way and not to interfere with existing public utility installations.
 - c. If at any time during the period of this Franchise City shall elect to alter or change the grade or location of any Right-of-Way, the Grantee shall, upon reasonable notice and in a manner consistent with applicable ordinances, remove and relocate its poles, wires, cables, conduits, manholes and other fixtures of the System.
 - d. The Grantee shall not place poles, conduits, or other fixtures of System above or below ground where the same will interfere with any gas, electric,

telephone, water or other utility fixtures and all such poles, conduits, or other fixtures placed in any Right-of-Way shall be so placed as to comply with all requirements of the City.

- e. The Grantee shall, upon request of any Person holding a moving permit issued by City, temporarily move its wires or fixtures to permit the moving of buildings with the expense of such temporary removal to be paid by the Person requesting the same, and the Grantee shall be given not less than ten (10) days advance notice to arrange for such temporary changes.
 - f. The Grantee shall have the authority to trim any trees upon and overhanging the Rights-of-Way only to the extent necessary to prevent the branches of such trees from coming in contact with the wires and cables of the Grantee.
4. Undergrounding of Cable. Grantee shall place its System and facilities underground in areas of the City where all other utility lines are placed underground. Amplifier boxes and pedestal mounted terminal boxes may be placed above ground if existing technology reasonably requires, but shall be of such size and design and shall be so located as not to be unsightly or unsafe, all as may be approved by City in accordance with applicable requirements.
5. Drop Burial. Grantee shall bury all Drops within a reasonable time not to exceed thirty (30) days except during periods when the ground is frozen.
6. Safety Requirements.
- a. The Grantee shall at all times employ ordinary and reasonable care and shall install and maintain in use nothing less than commonly accepted methods and devices for preventing failures and accidents which are likely to cause damage, injuries, or nuisances to the public.
 - b. The Grantee shall install and maintain its System and other equipment and facilities in accordance with all federal, state and local laws and regulations, and the requirements of the National Electric Safety Code and in such manner that they will not interfere with private radio, police and fire communications or any installations of City or of any public utility serving City.
 - c. All System structures, and lines, equipment and connections in, over, under and upon the Rights-of-Way, wherever situated or located, shall at all times be kept and maintained in good condition, order, and repair so that the same shall not menace or endanger the life or property of the City or any Person.
7. Emergency Alert System. To the extent required by the FCC's regulations, the Grantee shall provide an Emergency Alert System ("EAS") which shall be operated and available to the City in the event of an emergency or disaster. To the extent provided by law, the City will ~~hold~~hold the Grantee harmless from any claims arising out of the City's use of EAS.

SECTION 4.

DESIGN PROVISIONS

1. Operation and Maintenance of System. The Grantee shall render good quality Service, make repairs promptly, and interrupt Service only for good cause and for the shortest time possible. The Grantee shall operate and maintain the System to provide a minimum of one hundred (100) video programmed channels.
2. Technical Standards. The technical standards used in the operation of the System shall comply, at minimum, with the technical standards promulgated by the FCC relating to Cable Systems pursuant to Code of Federal Regulations Title 47, Section 76.601 to 76.617, as may be amended or modified from time to time, which regulations are expressly incorporated herein by reference.
3. System Testing. The City may review FCC and other technical reports provided by the Grantee or procured by the City at any time. The City may engage any consultant, engineer or expert to perform such testing and review as it deems necessary. The City shall endeavor to so arrange its request for such special testing to minimize hardship or inconvenience to Grantee or to the Subscribers. Before ordering such special tests, Grantee shall be afforded ten (10) days to correct problems or complaints upon which tests were ordered. If the performance difficulty resulting in noncompliance is not resolved, in City's reasonable determination, after the ten (10) day cure period has elapsed, the tests shall be conducted by a qualified consultant selected by City. The costs of special testing shall be borne by the Grantee.
4. FCC Reports. Upon written request from the City, the results of any tests required to be filed by Grantee with the FCC shall be provided to the City or its designee within ten (10) days of the receipt of the written request.
5. Nonvoice Return Capability. Grantee is required to use cable having the technical capacity for nonvoice return communications.

SECTION 5.

SERVICES PROVISIONS

1. Regulation of Service Rates.
 - b. The City may regulate rates for the provision of Cable Service, equipment, or any other communications service provided over the System to the extent allowed under federal or state law(s).
 - c. A list of Grantee's current Subscriber rates and charges shall be maintained on file with the City and shall be available for public inspection. Grantee shall give the City and Subscribers written notice of any change in a rate or charge no less than thirty (30) days prior to the effective date of the change.

2. Sales Procedures. Grantee shall not exercise deceptive sales procedures when marketing any of its services within City. Grantee shall have the right to market consistent with local ordinances and other applicable laws and regulations.
3. Customer Service.
 - a. FCC Standards. Grantee shall comply with the FCC's customer service regulations and requirements governing installations, repair of outages, service calls, and telephone answer time and busy signals. The FCC's requirements are attached hereto as Exhibit A, and incorporated by reference.
 - b. Availability. Grantee will maintain a local, toll-free telephone number which will be available to its Subscribers 24 hours a day, seven days a week to receive Subscriber complaints, requests, and inquiries. During normal business hours, Grantee shall ensure that trained representatives are available to respond to Subscriber inquiries.
4. Complaint Records Upon request by the City, Grantee shall provide copies of written complaints received.
5. Billing and Subscriber Communications. Grantee must give Subscribers thirty (30) days advance written notice with copy to City before any changes in rates, programming services, or channel positions.
6. Subscriber Contracts. Grantee shall file with the City any standard form Subscriber contract utilized by Grantee.
7. Refunds and Credits. In the event a Subscriber established or terminates Service and receives less than a full month's Service, Grantee shall prorate the monthly rate on the basis of the number of days in the period for which Service was rendered to the number of days in the billing.
- ~~8. Additional Customer Service Requirements. The City expressly reserves authority to adopt additional or modified customer service requirements to address Subscriber concerns or complaints in accordance with law.~~

SECTION 6.

ACCESS CHANNEL(S) PROVISIONS

1. Public, Educational and Government Access. Grantee shall dedicate one (1) channel (channel 8) for public, educational or governmental (PEG) use. All Subscribers who receive Service on the System shall receive the PEG access channel at no extra charge. The City or its designee is authorized to operate the PEG channel. The City may use the PEG channel to cablecast character generated programming or other video programming. The City may also make the channel available for use by the public or local educational authorities. Nothing herein shall diminish the City's rights pursuant to Minn. Stat. § 238.084 to obtain additional channels.

2. Charges for Use. If the City elects to make the PEG access channel available to the public, channel time and playback of programming on the channel will be provided without charge.
3. Access Equipment. Grantee shall replace the City's existing character generator within sixty (60) days of a written request by City. Further, in the event the City determines to begin cablecasting City Council meetings or other public meetings/events, the City may notify the Grantee that it desires a camera and such other equipment as it reasonably determines is necessary in order to cablecast such meetings. Grantee shall thereafter provide technical assistance for the repair ~~or~~ replaceof such equipment as needed to ensure that it remains fully operational.

SECTION 7.

OPERATION AND ADMINISTRATION PROVISIONS

1. Franchise Fee.
 - a. Grantee shall pay a Franchise Fee of five percent (5%) of its annual Gross Revenues to the City. Annual Gross Revenues shall exclude installation cost and state and federal fees.
 - b. Payments shall be made quarterly within ninety (90) days of the end of each of each calendar quarter together with a report in form reasonably acceptable to City that shows the basis for the computation.
 - c. All amounts paid shall be subject to audit by the City. Acceptance of any payment shall not be construed as an accord that the amount paid is in fact the correct amount.
2. Access to Records. The City shall have the right to inspect any records maintained by Grantee which relate to this Franchise or System operations including specifically Grantee's accounting and financial records, subject to the privacy provisions of 47 U.S.C. § 521 et seq. Grantee shall provide copies of any such records upon request by City.

SECTION 8.

GENERAL FINANCIAL, INSURANCE AND SECURITY PROVISIONS

1. Bond. If the City so requests, the Grantee shall furnish a bond to the City, in favor of the City, in the amount of Fifty Thousand Dollars (\$50,000.00) in a form and with such sureties as are reasonably acceptable to the City. The bond shall be conditioned upon the faithful performance of the Grantee according to the terms of the Franchise and upon the further condition that in the event the Grantee shall fail to comply with any law, ordinance, regulation, or the Franchise, there shall be recoverable jointly and severally from the principal and surety of the bond any damages or loss suffered by the City as a result including the full amount of any compensation, indemnification or

cost of removal or abandonment of any property of the Grantee, plus a reasonable allowance for attorneys' fees and costs, up to the full amount of the bond, and further guaranteeing payment by the Grantee of claims, liens and taxes due the City which arise by reason of the construction, operation, or maintenance of the System. The City may, from year to year, in its sole discretion, reduce the amount of the bond. The rights reserved to the City with respect to the performance bond shall not be deemed an exclusive remedy and are in addition to all other rights of the City. The bond amount shall in no way limit the extent of Grantee's liability to City.

~~2. Liquidated Damages. In addition to any other remedies, the City may impose, and shall be entitled to receive as liquidated damages, \$150 per day, per violation, for any material violations of this Franchise or applicable laws or regulations. The following procedure shall apply:~~

~~a. Whenever the City finds that Grantee has allegedly violated this Franchise or applicable laws or regulations, the City shall give written notice to Grantee specifying the alleged violation.~~

~~b. Grantee shall have ten (10) days from receipt of a violation notice to cure or notify the City that there is a dispute as to whether a violation has, in fact, occurred. Such notice by Grantee shall specify the matters disputed by Grantee.~~

~~c. In the event Grantee does not cure and does not dispute the violation, liquidated damages shall begin to accrue and the City may demand payment of such damages by Grantee and, in the event of non payment, make claim against Grantee's bond.~~

~~d. In the event Grantee disputes the violation, the City Council shall hear Grantee's dispute at a regular or special meeting. Grantee shall have an opportunity to present testimony, evidence and argument. The City Council shall determine if a violation occurred and make written findings of fact. Liquidated damages shall begin to accrue from the date of the City Council's determination.~~

~~e. The City may extend the time for cure in the event Grantee timely begins efforts to correct or cure a violation and the failure to complete such cure stay is due to circumstances beyond the Grantee's reasonable control.~~

2. ~~3.~~ Indemnification.

a. The City and its officers, boards, committees, elected officials, employees and agents shall not be liable for any loss or damage to any real or personal property of any Person, or for any injury to or death of any Person, arising out of or in connection with the construction, operation, maintenance, repair or removal of, or other action or event with respect to the System or as to any other action or event with respect to this Franchise.

- b. Grantee shall indemnify, defend, and hold harmless the City, its officers, boards, committees, elected officials, employees and agents from and against all liability, damages, and penalties which they may legally be required to pay as a result of the actions or omissions of the Grantee operating under this Franchise.
- c. Nothing in this Franchise relieves a Person, except the City, from liability arising out of the failure to exercise reasonable care to avoid injuring the Grantee's facilities while performing work connected with grading, regarding, or changing the line of a Right-of-Way or public place or with the construction or reconstruction of a sewer or water system.

3. ~~4.~~ Insurance.

- a. Grantee shall file with its acceptance of this Franchise, and at all times thereafter maintain in full force and effect at its sole expense, a comprehensive general liability insurance policy, ~~including broadcaster's/cablecaster's liability~~ and contractual liability coverage, in protection of the Grantee, and the City, its officers, boards, committees, elected officials, employees and agents for any and all damages and penalties which may arise as a result of this Franchise. The policy or policies shall name the City as an additional insured, ~~and in their capacity as such, the City officers, boards, committees, elected officials, employees and agents.~~
- b. The policies of insurance shall be in the sum of not less than One Million Dollars (\$1,000,000.00) for personal injury or death of any one Person, and Two Million Dollars (\$2,000,000.00) for personal injury or death of two or more Persons in any one occurrence, One Million Dollars (\$1,000,000.00) for property damage to any one person and Two Million Dollars (\$2,000,000.00) for property damage resulting from any one act or occurrence.
- c. The policy or policies of insurance shall be maintained by Grantee in full force and effect during the entire term of the Franchise. Each policy of insurance shall contain a statement on its face that the insurer will not cancel the policy or fail to renew the policy, whether for nonpayment of premium, or otherwise, and whether at the request of Grantee or for other reasons, except after sixty (60) days advance written notice have been provided to the City.

SECTION 9.

SALE, ABANDONMENT, AND TRANSFER OF FRANCHISE

- 1. Abandonment of Service. Grantee may not abandon the System or any portion thereof without having first given three (3) months written notice to the City. ~~In the event of abandonment, Grantee shall be obligated to pay additional amounts owed pursuant to this Franchise along with liquidated damages for each day remaining in~~

~~the Franchise term.~~ Grantee may not abandon any portion of the System or Service without compensating the City for damages resulting from such abandonment.

2. Removal After Abandonment, Termination or Forfeiture. In the event of termination or forfeiture of the Franchise or abandonment of the System, the City shall have the right to require Grantee to remove all or any portion of the System from all Rights-of-Way and public property within the City.
3. Sale or Transfer of Franchise.
 - a. No sale, transfer, or fundamental corporate change of or in Grantee, or which creates a new controlling interest in Grantee, including, but not limited to, the sale of a majority of Grantee's assets, consolidation, or the creation of a subsidiary or affiliate entity, shall take place until the parties to the sale, transfer, or corporate change file a written request with the City for its approval and such approval is granted by the City, provided, however, that said approval shall not be required where Grantee grants a security interest in its Franchise and assets to secure an indebtedness.
 - b. Any sale, transfer, exchange or assignment of stock in Grantee so as to create a new controlling interest in the System shall be subject to the requirements of this Section 9.03. The term "controlling interest" as used herein is not limited to majority stock ownership, but includes actual working control in whatever manner exercised.
 - c. The City shall have such time as is permitted by applicable law in which to review a transfer request, but in no event less than one hundred and twenty (120) days.
 - d. The Grantee shall reimburse City for all the reasonable legal, administrative, and consulting costs and fees associated with the City's review of any request to transfer. Such reimbursement of City's costs and fees shall not constitute a Franchise Fee. Nothing herein shall prevent Grantee from negotiating partial or complete payment of such costs and fees by the transferee. Any fees paid will be assessed against the Franchise Fee.
 - e. In no event shall a sale, transfer, corporate change, or assignment of ownership or control pursuant to Subparagraph (a) or (b) of this Section be approved without the transferee becoming a signatory to this Franchise and assuming all rights and obligations hereunder, and assuming all other rights and obligations of the transferor to the City.
 - f. In the event of any proposed sale, transfer, corporate change, or assignment pursuant to subparagraph (a) or (b) of this Section, the City shall have the right of first refusal of any bona fide offer to purchase the System. A complete copy of any written offer to purchase the system must be conveyed

to the City along with the Grantee's written acceptance of the offer contingent upon the rights of the City provided for in this Section.

The City shall be deemed to have waived its rights under this Section in the following circumstances:

- i. If it does not indicate to Grantee in writing, within thirty (30) days of notice of a proposed sale or assignment, its intention to exercise its right of purchase; or
- ii. It approves the assignment or sale of the Franchise as provided within this Section.

SECTION 10.

REVOCAION OF FRANCHISE

1. City's Right to Revoke. In addition to all other rights which the City has pursuant to law or equity, the City reserves the right to revoke, terminate or cancel this Franchise, and all rights and privileges pertaining thereto, if it is determined that Grantee has violated any material provision of this Franchise, has made intentional misrepresentations to City, or has practiced fraud or deceit upon the City of a Subscriber. The City may revoke this Franchise immediately if Grantee is adjudged bankrupt.
2. Procedures.
 - a. The City shall provide Grantee with written notice of the cause for revocation and its intent to revoke and shall allow Grantee sixty (60) days to cure the violation.
 - b. Grantee shall be provided the right to a public hearing affording due process prior to revocation, which public hearing shall follow the cure period. The City shall provide Grantee with written notice of its decision together with written findings of fact supplementing said decision.
 - c. After such public hearing and release of written findings, the City may revoke the Franchise. Grantee may appeal such revocation to a court or agency of competent jurisdiction.
 - d. During the appeal period, Grantee may continue to operate the System pursuant to the terms and conditions of the Franchise, unless the term thereof sooner expires.

SECTION 11.

PROTECTION OF INDIVIDUAL RIGHTS

1. Discriminatory Practices Prohibited. Grantee shall not deny service, deny access, or otherwise discriminate against Subscribers or general citizens on the basis of race, color, religion, national origin, sex, age, status as to public assistance, affectional preference, or disability. Grantee shall comply at all times with all other applicable federal, state, and local laws, and all executive and administrative orders relating to nondiscrimination.
2. Subscriber Privacy.
 - a. Grantee shall comply with the subscriber privacy-related requirements of 47 U.S.C. § 551. No signals including signals of a Class IV Channel may be transmitted from a Subscriber terminal for purposes of monitoring individual viewing patterns or practices without the express written permission of the Subscriber. Such written permission shall be for a limited period of time not to exceed one (1) year which may be renewed at the option of the Subscriber. No penalty shall be invoked for a Subscriber's failure to provide or renew such authorization. The authorization shall be revocable at any time by the Subscriber without penalty of any kind whatsoever. Such permission shall be required for each type or classification of Class IV Channel activity planned for the purpose of monitoring individual viewing patterns or practices.
 - b. No lists of the names and addresses of Subscribers or any lists that identify the viewing habits of Subscribers shall be sold or otherwise made available to any party other than to Grantee ~~and~~, its employees and contractors, for internal business use, and also to the Subscriber subject of that information, unless Grantee has received specific written authorization from the Subscriber to make such data available. Nothing herein shall preclude Grantee from providing data to programming suppliers per their contracts. Such written permission shall be for a limited period of time not to exceed one (1) year which may be renewed at the option of the Subscriber. No penalty shall be invoked for a Subscriber's failure to provide or renew such authorization. The authorization shall be revocable at any time by the Subscriber without penalty of any kind whatsoever.
 - c. Written permission from the Subscriber shall not be required for the conducting of System wide or individually addressed electronic sweeps for the purpose of verifying System integrity or monitoring for the purpose of billing. Confidentiality of such information shall be subject to the provision set forth in Subparagraph (b) of this Section.

SECTION 12.

MISCELLANEOUS PROVISIONS

1. Franchise Renewal. Any renewal of this Franchise shall be performed in accordance with applicable federal, state and local laws and regulations.

2. Compliance with Federal, State and Local Laws.
 - a. Grantee and the City shall conform to state laws and rules regarding cable communications not later than one year after they become effective, unless otherwise stated, and to conform to federal laws and regulations regarding cable as they become effective.
 - b. If any term, condition or provision of this Franchise or the application thereof to any Person or circumstance shall, to any extent, be held to be invalid or unenforceable, the remainder hereof and the application of such term, condition or provision to Persons or circumstances other than those as to whom it shall be held invalid or unenforceable shall not be affected thereby, and this Franchise and all the terms, provisions and conditions hereof shall, in all other respects, continue to be effective and complied with provided the loss of the invalid or unenforceable clause does not substantially alter the agreement between the parties.
3. Nonenforcement by City. Grantee shall not be relieved of its obligations to comply with any of the provisions of this Franchise by reason of any failure or delay of the City to enforce prompt compliance. The City and the Grantee may only waive its rights hereunder by expressly so stating in writing. Any such written waiver by the City of a breach or violation of any provision of this Franchise shall not operate as or be construed to be a waiver of any subsequent breach or violation.
4. Rights Cumulative. All rights and remedies under this Franchise or retained by the City herein are not exclusive but are in addition to other rights and remedies available to the City. The exercise of remedies herein does not constitute the waiver of any other remedies.
5. Grantee Acknowledgment of Validity of Franchise. Grantee acknowledges that the terms and conditions of this Franchise are consistent with current law and are not unreasonable or arbitrary.

SECTION 13.

PUBLICATION EFFECTIVE DATE; ACCEPTANCE AND EXHIBITS

1. Acceptance. Grantee shall accept this Franchise within sixty (60) of its enactment by the City, unless the time for acceptance is extended by the City. Upon acceptance of this Franchise, Grantee shall be bound by all the terms and conditions contained herein. Grantee shall accept this Franchise by properly executing, acknowledging, and returning the Franchise to the City, and by delivering the performance bond and certificate of insurance required herein.
2. Publication: Effective Date. This Franchise shall be published in accordance with applicable local and Minnesota law. The Effective Date of this Franchise shall be the date of acceptance by Grantee.

ORDINANCE NO. 115 (SECOND SERIES)

AN ORDINANCE GRANTING A FRANCHISE TO PINE ISLAND TELEPHONE COMPANY TO CONSTRUCT, OPERATE, AND MAINTAIN A CABLE SYSTEM IN THE CITY OF PINE ISLAND, MINNESOTA; SETTING FORTH CONDITIONS ACCOMPANYING THE GRANT OF THE FRANCHISE; REGULATING OPERATION AND USE OF THE SYSTEM AND PUBLIC RIGHTS-OF-WAY, AND; PRESCRIBING PENALTIES FOR VIOLATIONS OF ITS PROVISIONS

The City of Pine Island (“City”) ordains:

STATEMENT OF INTENT AND PURPOSE

The City intends, by the adoption of this Franchise, to bring about the continued operation and further development of a Cable System. Such a development can contribute significantly to the communication needs and desires of residents of the City. Further, the City may achieve better utilization and improvement of public services with the development and operation of the Cable System. Adoption of this Franchise is, in the judgment of the Council, in the best interests of the City, its residents, and the community.

FINDINGS

The City makes the following findings:

1. Pine Island Telephone Company (“Grantee”) requested renewal of its franchise on or about October 17, 2011, and;
2. Grantee’s prior cable franchise, Ordinance No. 26 Second Series, expired on or about September 18, 2011, and;
3. This Franchise complies with the existing applicable Minnesota Statutes, federal laws and regulations.

SECTION 1.

SHORT TITLE AND DEFINITIONS

1. Short Title. This Franchise Ordinance shall be known and cited as the Cable Communications Ordinance.
2. Definitions. For the purposes of this Franchise, the following terms, phrases, words, and their derivations shall have the meaning given herein. When not inconsistent with the context, words in the singular number include the plural number. The words “shall” or “must” are always mandatory and not merely directory. The word “may” is directory and discretionary and not mandatory.

- a. “Basic Cable Service” means any service tier which includes the lawful retransmission of local television broadcast signals and any public, educational, and governmental access programming required by the Franchise to be carried on the basic tier. Basic Cable Service as defined herein shall not be inconsistent with 47 U.S.C. § 543(b)(7) (1993).
- b. “Cable Service” or “Service” means the provision of television reception, communications and/or entertainment services regulated pursuant to Minn. Stat. § 238.01 et seq. as may be amended from time to time, or as otherwise provided by this Franchise, and distributing the same over a Cable System.
- c. “Cable System” or “System” means a system of antennas, cables, wires, lines, towers, waveguides, or other conductors, converters, equipment, or facilities located in the City and designed and constructed for the purpose of producing, receiving, transmitting, amplifying, or distributing audio, video, and other forms of electronic signals in the City. System as defined herein is consistent with the definition set forth in Minn. Stat. § 238.02, subd. 3.
- d. “City” means the City of Pine Island, Minnesota, acting by and through its City Council.
- e. “Drop” means the cable that connects the ground block on the Subscriber’s residence to the nearest feeder cable of the System.
- f. “FCC” means the Federal Communications Commission and any legally appointed, designated or elected agent or successor.
- g. “Franchise” means this ordinance and the regulatory and contractual relationship established hereby.
- h. “Franchise Fee” means a fee or assessment imposed by the City on a Grantee solely because of its status as a recipient of a Cable Franchise. The term “Franchise Fee” does not include: (i) any tax, fee or assessment of general applicability; (ii) any payments which are required by this Franchise for, or in support of the use of, public, educational, or governmental access facilities; (iii) requirements or charges incidental to awarding or enforcing this Franchise, including payments for bonds, security funds or letters of credit, insurance, indemnification, penalties or liquidated damages; (v) any fee imposed under Title 17 of the United States Code.
- i. “Grantee” is Pine Island Telephone Company, its agents and employees, and lawful successors, transferees or assignees.
- j. “Gross Revenues” means all revenue received by the Grantee from the

operation of its System to provide Cable Service in the City.

- k. “Installation” means the connection of the System from feeder cable to the point of connection, including any standard installation and any custom installation.
- l. “Person” is any person, firm, partnership, association, corporation, company, or other legal entity.
- m. “Right-of-Way” or “Rights-of-Way” means the area on, below, or above any real property in the City in which City has an interest including, but not limited to any street, road, highway, alley, sidewalk, parkway, park, skyway, or any other place, area, or real property owned by or under the control of the City, including any other Rights-of-Way dedicated for travel purposes and utility easements.
- n. “Right-of-Way Ordinance” means any ordinance adopted by the City creating requirements regarding regulation, permitting, management and use of Rights-of-Way.
- o. “Subscriber” means any Person who lawfully receives Service via the System.

SECTION 2.

GRANT OF AUTHORITY AND GENERAL PROVISIONS

1. Franchise Required. It shall be unlawful for any Person to construct, operate or maintain a Cable System or provide Cable Service in City unless such Person shall first obtain and hold a valid franchise.
2. Grant of Franchise. This Franchise is granted pursuant to the terms and conditions contained herein. At the time of acceptance of this Franchise, Grantee shall reimburse the City for all reasonable costs and fees incurred in processing and awarding this franchise. The Grantee may treat such reimbursement as a franchise fee to the extent permitted by applicable law.
3. Grant of Nonexclusive Authority.
 - a. The Grantee shall have the right and privilege pursuant to this Franchise, subject to the requirements of any applicable ordinance, rule or procedure, to construct, erect, operate and maintain a Cable System in, upon, along, across, above, over and under the Rights-of-Way in the City and shall have the right and privilege to provide Cable Service. The System constructed and maintained by Grantee shall not interfere with other uses of the Rights-of-Way. Grantee shall make use of existing poles and other above and below-ground facilities available to Grantee to the extent it is technically and

economically feasible to do so.

- b. Notwithstanding the above grant to use Rights-of-Way, use of such Rights-of-Way shall not be inconsistent with the terms and conditions by which they were created or dedicated, with the present use thereof, and with all legal requirements related to the use thereof including the terms and conditions of any applicable Right-of-Way Ordinance.
 - c. This Franchise shall be nonexclusive and City reserves the right to grant similar use to any Person at any time during the term of this Franchise.
 - d. The City may require all developers of future subdivisions to allow and accommodate the construction of the System as part of any provisions for utilities to serve such subdivisions.
5. Franchise Term. This Franchise shall be in effect for a period of fifteen (15) years from the date of acceptance by Grantee, unless sooner renewed, revoked, or terminated as provided herein.
 6. Previous Franchises. This Franchise supersedes and replaces expired Ordinance No. 26 Second Series.
 7. Compliance with Applicable Laws, Resolutions and Ordinances. The Grantee shall at all times during the term of this Franchise be subject to all lawful exercise of the police power, statutory rights, local ordinance-making authority, and eminent domain rights of the City. This Franchise shall comply with Minnesota franchise standards contained in Minn. Stat. § 238.01 et seq.
 8. Territorial Area Involved/Service Extension.
 - a. This Franchise is granted for the corporate boundaries of the City, as it exists from time to time. Grantee shall be required to extend Service without charge to any requesting Person or area within the City in which Service is requested.
 - b. Grantee shall construct and activate plant to provide Service within a reasonable time.
 - c. Access to Service shall not be denied to any group of potential residential cable Subscribers because of the income of the residents of the area in which such group resides.
 9. Written Notice. All notices, reports, or demands required to be given in writing under this Franchise shall be deemed to be given when delivered personally to any officer of Grantee or City's Administrator of this Franchise or forty-eight (48) hours after it is deposited in the United States mail in a sealed envelope, with registered or certified mail postage prepaid thereon, addressed to the party to whom notice is being given, as follows:

Such addresses may be changed by either party upon notice to the other party given as provided in this Section.

10. Cable Service to Public Buildings. Grantee shall provide without charge, Installation of one (1) cable Drop, one (1) cable outlet, and monthly Basic Cable Service without charge to the City Hall, City Public Works Department, Pine Island schools (including any relocated facilities), Fire Hall, and the City garage. Within a reasonable time of a written request by City, the Drop at City Hall shall be two-way activated permitting cablecasting of live or recorded programming from such location. No redistribution of the free Service provided pursuant to this Section shall be allowed without the Grantee's prior written consent.

SECTION 3.

CONSTRUCTION STANDARDS

1. Construction Codes and Permits.
 - a. Grantee shall obtain all lawful and necessary permits from City before commencing any construction or extension of System, including the opening or disturbance of any Right-of-Way, or private or public property within City. Grantee shall comply with all state and local laws and building and zoning codes currently or hereafter applicable to location, construction, installation, operation or maintenance of the System in the City and give due consideration at all times to the aesthetics of the property.
 - b. Consistent with its ROW ordinance, the City shall have the right to inspect all construction or installation work performed pursuant to the provisions of the Franchise and to make such tests as it shall find necessary to ensure compliance with the terms of the Franchise and applicable provisions of local, state and federal law.
2. Repair of Rights-of-Way and Property. Any and all Rights-of-Way or public or private property, which are disturbed or damaged during the construction, repair, replacement, relocation, operation, maintenance or reconstruction of the System shall be promptly and fully restored by Grantee, at its expense, in accordance with the

ROW Ordinance and, in any case, to the same condition as that prevailing prior to Grantee's work, as approved by City in the case of Rights-of-Way and other public property. If Grantee fails to promptly perform the restoration required herein after 30 days' notice from City, City may perform the restoration of the Rights-of-Way, public, or private property as required herein at Grantee's expense.

3. Conditions on Right-of-Way Use.

- a. Nothing in this Franchise shall be construed to prevent City from adopting and enforcing requirements for the usage of Rights-of-Way or from constructing, maintaining, repairing or relocating sewers; grading, paving, maintaining, repairing, relocating and/or altering any Right-of-Way; constructing, laying down, repairing, maintaining or relocating any water mains; or constructing, maintaining, relocating, or repairing any sidewalk or other public work.
- b. Upon the City's written request the Grantee shall provide a complete set of facility maps showing the routing of the Cable System plant and facilities in the Streets, but excluding detail on proprietary electronics or other proprietary information that is related to Grantee's specific design of the Cable System contained therein and Subscriber Drops. The maps may be provided in an electronic format acceptable to the City. Upon written request, Grantee shall also provide facility map updates. All such maps and data given to the City shall be considered to be trade secret and not used for any competitive purposes. All System transmission and distribution structures, lines and equipment erected by the Grantee shall be located so as not to obstruct or interfere with the use of Right-of-Way and to cause minimum interference with the rights of property owners who abut any of said Right-of-Way and not to interfere with existing public utility installations.
- c. If at any time during the period of this Franchise City shall elect to alter or change the grade or location of any Right-of-Way, the Grantee shall, upon reasonable notice and in a manner consistent with applicable ordinances, remove and relocate its poles, wires, cables, conduits, manholes and other fixtures of the System.
- d. The Grantee shall not place poles, conduits, or other fixtures of System above or below ground where the same will interfere with any gas, electric, telephone, water or other utility fixtures and all such poles, conduits, or other fixtures placed in any Right-of-Way shall be so placed as to comply with all requirements of the City.
- e. The Grantee shall, upon request of any Person holding a moving permit issued by City, temporarily move its wires or fixtures to permit the moving of buildings with the expense of such temporary removal to be paid by the Person requesting the same, and the Grantee shall be given not less than ten (10) days advance notice to arrange for such temporary changes.

- f. The Grantee shall have the authority to trim any trees upon and overhanging the Rights-of-Way only to the extent necessary to prevent the branches of such trees from coming in contact with the wires and cables of the Grantee.
4. Undergrounding of Cable. Grantee shall place its System and facilities underground in areas of the City where all other utility lines are placed underground. Amplifier boxes and pedestal mounted terminal boxes may be placed above ground if existing technology reasonably requires, but shall be of such size and design and shall be so located as not to be unsightly or unsafe, all as may be approved by City in accordance with applicable requirements.
5. Drop Burial. Grantee shall bury all Drops within a reasonable time not to exceed thirty (30) days except during periods when the ground is frozen.
6. Safety Requirements.
 - a. The Grantee shall at all times employ ordinary and reasonable care and shall install and maintain in use nothing less than commonly accepted methods and devices for preventing failures and accidents which are likely to cause damage, injuries, or nuisances to the public.
 - b. The Grantee shall install and maintain its System and other equipment and facilities in accordance with all federal, state and local laws and regulations, and the requirements of the National Electric Safety Code and in such manner that they will not interfere with private radio, police and fire communications or any installations of City or of any public utility serving City.
 - c. All System structures, and lines, equipment and connections in, over, under and upon the Rights-of-Way, wherever situated or located, shall at all times be kept and maintained in good condition, order, and repair so that the same shall not menace or endanger the life or property of the City or any Person.
7. Emergency Alert System. To the extent required by the FCC's regulations, the Grantee shall provide an Emergency Alert System ("EAS") which shall be operated and available to the City in the event of an emergency or disaster. To the extent provided by law, the City will hold the Grantee harmless from any claims arising out of the City's use of EAS.

SECTION 4.

DESIGN PROVISIONS

1. Operation and Maintenance of System. The Grantee shall render good quality Service, make repairs promptly, and interrupt Service only for good cause and for the shortest time possible. The Grantee shall operate and maintain the System to provide a minimum of one hundred (100) video programmed channels.
2. Technical Standards. The technical standards used in the operation of the System

shall comply, at minimum, with the technical standards promulgated by the FCC relating to Cable Systems pursuant to Code of Federal Regulations Title 47, Section 76.601 to 76.617, as may be amended or modified from time to time, which regulations are expressly incorporated herein by reference.

3. System Testing. The City may review FCC and other technical reports provided by the Grantee or procured by the City at any time. The City may engage any consultant, engineer or expert to perform such testing and review as it deems necessary. The City shall endeavor to so arrange its request for such special testing to minimize hardship or inconvenience to Grantee or to the Subscribers. Before ordering such special tests, Grantee shall be afforded ten (10) days to correct problems or complaints upon which tests were ordered. If the performance difficulty resulting in noncompliance is not resolved, in City's reasonable determination, after the ten (10) day cure period has elapsed, the tests shall be conducted by a qualified consultant selected by City. The costs of special testing shall be borne by the Grantee.
4. FCC Reports. Upon written request from the City, the results of any tests required to be filed by Grantee with the FCC shall be provided to the City or its designee within ten (10) days of the receipt of the written request.
5. Nonvoice Return Capability. Grantee is required to use cable having the technical capacity for nonvoice return communications.

SECTION 5.

SERVICES PROVISIONS

1. Regulation of Service Rates.
 - b. The City may regulate rates for the provision of Cable Service, equipment, or any other communications service provided over the System to the extent allowed under federal or state law(s).
 - c. A list of Grantee's current Subscriber rates and charges shall be maintained on file with the City and shall be available for public inspection. Grantee shall give the City and Subscribers written notice of any change in a rate or charge no less than thirty (30) days prior to the effective date of the change.
2. Sales Procedures. Grantee shall not exercise deceptive sales procedures when marketing any of its services within City. Grantee shall have the right to market consistent with local ordinances and other applicable laws and regulations.
3. Customer Service.
 - a. FCC Standards. Grantee shall comply with the FCC's customer service regulations and requirements governing installations, repair of outages, service calls, and telephone answer time and busy signals. The FCC's

requirements are attached hereto as Exhibit A, and incorporated by reference.

- b. Availability. Grantee will maintain a local, toll-free telephone number which will be available to its Subscribers 24 hours a day, seven days a week to receive Subscriber complaints, requests, and inquiries. During normal business hours, Grantee shall ensure that trained representatives are available to respond to Subscriber inquiries.
4. Complaint Records Upon request by the City, Grantee shall provide copies of written complaints received.
5. Billing and Subscriber Communications. Grantee must give Subscribers thirty (30) days advance written notice with copy to City before any changes in rates, programming services, or channel positions.
6. Subscriber Contracts. Grantee shall file with the City any standard form Subscriber contract utilized by Grantee.
7. Refunds and Credits. In the event a Subscriber established or terminates Service and receives less than a full month's Service, Grantee shall prorate the monthly rate on the basis of the number of days in the period for which Service was rendered to the number of days in the billing.

SECTION 6.

ACCESS CHANNEL(S) PROVISIONS

1. Public, Educational and Government Access. Grantee shall dedicate one (1) channel (channel 8) for public, educational or governmental (PEG) use. All Subscribers who receive Service on the System shall receive the PEG access channel at no extra charge. The City or its designee is authorized to operate the PEG channel. The City may use the PEG channel to cablecast character generated programming or other video programming. The City may also make the channel available for use by the public or local educational authorities. Nothing herein shall diminish the City's rights pursuant to Minn. Stat. § 238.084 to obtain additional channels.
2. Charges for Use. If the City elects to make the PEG access channel available to the public, channel time and playback of programming on the channel will be provided without charge.
3. Access Equipment. Grantee shall replace the City's existing character generator within sixty (60) days of a written request by City. Further, in the event the City determines to begin cablecasting City Council meetings or other public meetings/events, the City may notify the Grantee that it desires a camera and such other equipment as it reasonably determines is necessary in order to cablecast such meetings. Grantee shall thereafter provide technical assistance for the repair of such equipment as needed to ensure that it remains fully operational.

SECTION 7.

OPERATION AND ADMINISTRATION PROVISIONS

1. Franchise Fee.
 - a. Grantee shall pay a Franchise Fee of five percent (5%) of its annual Gross Revenues to the City. Annual Gross Revenues shall exclude installation cost and state and federal fees.
 - b. Payments shall be made quarterly within ninety (90) days of the end of each of each calendar quarter together with a report in form reasonably acceptable to City that shows the basis for the computation.
 - c. All amounts paid shall be subject to audit by the City. Acceptance of any payment shall not be construed as an accord that the amount paid is in fact the correct amount.
2. Access to Records. The City shall have the right to inspect any records maintained by Grantee which relate to this Franchise or System operations including specifically Grantee's accounting and financial records, subject to the privacy provisions of 47 U.S.C. § 521 et seq. Grantee shall provide copies of any such records upon request by City.

SECTION 8.

GENERAL FINANCIAL, INSURANCE AND SECURITY PROVISIONS

1. Bond. If the City so requests, the Grantee shall furnish a bond to the City, in favor of the City, in the amount of Fifty Thousand Dollars (\$50,000.00) in a form and with such sureties as are reasonably acceptable to the City. The bond shall be conditioned upon the faithful performance of the Grantee according to the terms of the Franchise and upon the further condition that in the event the Grantee shall fail to comply with any law, ordinance, regulation, or the Franchise, there shall be recoverable jointly and severally from the principal and surety of the bond any damages or loss suffered by the City as a result including the full amount of any compensation, indemnification or cost of removal or abandonment of any property of the Grantee, plus a reasonable allowance for attorneys' fees and costs, up to the full amount of the bond, and further guaranteeing payment by the Grantee of claims, liens and taxes due the City which arise by reason of the construction, operation, or maintenance of the System. The City may, from year to year, in its sole discretion, reduce the amount of the bond. The rights reserved to the City with respect to the performance bond shall not be deemed an exclusive remedy and are in addition to all other rights of the City. The bond amount shall in no way limit the extent of Grantee's liability to City.
2. Indemnification.
 - a. The City and its officers, boards, committees, elected officials, employees

and agents shall not be liable for any loss or damage to any real or personal property of any Person, or for any injury to or death of any Person, arising out of or in connection with the construction, operation, maintenance, repair or removal of, or other action or event with respect to the System or as to any other action or event with respect to this Franchise.

- b. Grantee shall indemnify, defend, and hold harmless the City, its officers, boards, committees, elected officials, employees and agents from and against all liability, damages, and penalties which they may legally be required to pay as a result of the actions or omissions of the Grantee operating under this Franchise.
- c. Nothing in this Franchise relieves a Person, except the City, from liability arising out of the failure to exercise reasonable care to avoid injuring the Grantee's facilities while performing work connected with grading, regarding, or changing the line of a Right-of-Way or public place or with the construction or reconstruction of a sewer or water system.

3. Insurance.

- a. Grantee shall file with its acceptance of this Franchise, and at all times thereafter maintain in full force and effect at its sole expense, a comprehensive general liability insurance policy, and contractual liability coverage, in protection of the Grantee, and the City, its officers, boards, committees, elected officials, employees and agents for any and all damages and penalties which may arise as a result of this Franchise. The policy or policies shall name the City as an additional insured.
- b. The policies of insurance shall be in the sum of not less than One Million Dollars (\$1,000,000.00) for personal injury or death of any one Person, and Two Million Dollars (\$2,000,000.00) for personal injury or death of two or more Persons in any one occurrence, One Million Dollars (\$1,000,000.00) for property damage to any one person and Two Million Dollars (\$2,000,000.00) for property damage resulting from any one act or occurrence.
- c. The policy or policies of insurance shall be maintained by Grantee in full force and effect during the entire term of the Franchise. Each policy of insurance shall contain a statement on its face that the insurer will not cancel the policy or fail to renew the policy, whether for nonpayment of premium, or otherwise, and whether at the request of Grantee or for other reasons, except after sixty (60) days advance written notice have been provided to the City.

SECTION 9.

SALE, ABANDONMENT, AND TRANSFER OF FRANCHISE

- 1. Abandonment of Service. Grantee may not abandon the System or any portion thereof without having first given three (3) months written notice to the City.

Grantee may not abandon any portion of the System or Service without compensating the City for damages resulting from such abandonment.

2. Removal After Abandonment, Termination or Forfeiture. In the event of termination or forfeiture of the Franchise or abandonment of the System, the City shall have the right to require Grantee to remove all or any portion of the System from all Rights-of-Way and public property within the City.
3. Sale or Transfer of Franchise.
 - a. No sale, transfer, or fundamental corporate change of or in Grantee, or which creates a new controlling interest in Grantee, including, but not limited to, the sale of a majority of Grantee's assets, consolidation, or the creation of a subsidiary or affiliate entity, shall take place until the parties to the sale, transfer, or corporate change file a written request with the City for its approval and such approval is granted by the City, provided, however, that said approval shall not be required where Grantee grants a security interest in its Franchise and assets to secure an indebtedness.
 - b. Any sale, transfer, exchange or assignment of stock in Grantee so as to create a new controlling interest in the System shall be subject to the requirements of this Section 9.03. The term "controlling interest" as used herein is not limited to majority stock ownership, but includes actual working control in whatever manner exercised.
 - c. The City shall have such time as is permitted by applicable law in which to review a transfer request, but in no event less than one hundred and twenty (120) days.
 - d. The Grantee shall reimburse City for all the reasonable legal, administrative, and consulting costs and fees associated with the City's review of any request to transfer. Such reimbursement of City's costs and fees shall not constitute a Franchise Fee. Nothing herein shall prevent Grantee from negotiating partial or complete payment of such costs and fees by the transferee. Any fees paid will be assessed against the Franchise Fee.
 - e. In no event shall a sale, transfer, corporate change, or assignment of ownership or control pursuant to Subparagraph (a) or (b) of this Section be approved without the transferee becoming a signatory to this Franchise and assuming all rights and obligations hereunder, and assuming all other rights and obligations of the transferor to the City.
 - f. In the event of any proposed sale, transfer, corporate change, or assignment pursuant to subparagraph (a) or (b) of this Section, the City shall have the right of first refusal of any bona fide offer to purchase the System. A complete copy of any written offer to purchase the system must be conveyed to the City along with the Grantee's written acceptance of the offer contingent

upon the rights of the City provided for in this Section.

The City shall be deemed to have waived its rights under this Section in the following circumstances:

- i. If it does not indicate to Grantee in writing, within thirty (30) days of notice of a proposed sale or assignment, its intention to exercise its right of purchase; or
- ii. It approves the assignment or sale of the Franchise as provided within this Section.

SECTION 10.

REVOCAION OF FRANCHISE

1. City's Right to Revoke. In addition to all other rights which the City has pursuant to law or equity, the City reserves the right to revoke, terminate or cancel this Franchise, and all rights and privileges pertaining thereto, if it is determined that Grantee has violated any material provision of this Franchise, has made intentional misrepresentations to City, or has practiced fraud or deceit upon the City of a Subscriber. The City may revoke this Franchise immediately if Grantee is adjudged bankrupt.
2. Procedures.
 - a. The City shall provide Grantee with written notice of the cause for revocation and its intent to revoke and shall allow Grantee sixty (60) days to cure the violation.
 - b. Grantee shall be provided the right to a public hearing affording due process prior to revocation, which public hearing shall follow the cure period. The City shall provide Grantee with written notice of its decision together with written findings of fact supplementing said decision.
 - c. After such public hearing and release of written findings, the City may revoke the Franchise. Grantee may appeal such revocation to a court or agency of competent jurisdiction.
 - d. During the appeal period, Grantee may continue to operate the System pursuant to the terms and conditions of the Franchise, unless the term thereof sooner expires.

SECTION 11.

PROTECTION OF INDIVIDUAL RIGHTS

1. Discriminatory Practices Prohibited. Grantee shall not deny service, deny access, or otherwise discriminate against Subscribers or general citizens on the basis of race,

color, religion, national origin, sex, age, status as to public assistance, affectional preference, or disability. Grantee shall comply at all times with all other applicable federal, state, and local laws, and all executive and administrative orders relating to nondiscrimination.

2. Subscriber Privacy.

- a. Grantee shall comply with the subscriber privacy-related requirements of 47 U.S.C. § 551. No signals including signals of a Class IV Channel may be transmitted from a Subscriber terminal for purposes of monitoring individual viewing patterns or practices without the express written permission of the Subscriber. Such written permission shall be for a limited period of time not to exceed one (1) year which may be renewed at the option of the Subscriber. No penalty shall be invoked for a Subscriber's failure to provide or renew such authorization. The authorization shall be revocable at any time by the Subscriber without penalty of any kind whatsoever. Such permission shall be required for each type or classification of Class IV Channel activity planned for the purpose of monitoring individual viewing patterns or practices.
- b. No lists of the names and addresses of Subscribers or any lists that identify the viewing habits of Subscribers shall be sold or otherwise made available to any party other than to Grantee, its employees and contractors, for internal business use, and also to the Subscriber subject of that information, unless Grantee has received specific written authorization from the Subscriber to make such data available. Nothing herein shall preclude Grantee from providing data to programming suppliers per their contracts. Such written permission shall be for a limited period of time not to exceed one (1) year which may be renewed at the option of the Subscriber. No penalty shall be invoked for a Subscriber's failure to provide or renew such authorization. The authorization shall be revocable at any time by the Subscriber without penalty of any kind whatsoever.
- c. Written permission from the Subscriber shall not be required for the conducting of System wide or individually addressed electronic sweeps for the purpose of verifying System integrity or monitoring for the purpose of billing. Confidentiality of such information shall be subject to the provision set forth in Subparagraph (b) of this Section.

SECTION 12.

MISCELLANEOUS PROVISIONS

1. Franchise Renewal. Any renewal of this Franchise shall be performed in accordance with applicable federal, state and local laws and regulations.
2. Compliance with Federal, State and Local Laws.
 - a. Grantee and the City shall conform to state laws and rules regarding cable

communications not later than one year after they become effective, unless otherwise stated, and to conform to federal laws and regulations regarding cable as they become effective.

- b. If any term, condition or provision of this Franchise or the application thereof to any Person or circumstance shall, to any extent, be held to be invalid or unenforceable, the remainder hereof and the application of such term, condition or provision to Persons or circumstances other than those as to whom it shall be held invalid or unenforceable shall not be affected thereby, and this Franchise and all the terms, provisions and conditions hereof shall, in all other respects, continue to be effective and complied with provided the loss of the invalid or unenforceable clause does not substantially alter the agreement between the parties.
3. Nonenforcement by City. Grantee shall not be relieved of its obligations to comply with any of the provisions of this Franchise by reason of any failure or delay of the City to enforce prompt compliance. The City and the Grantee may only waive its rights hereunder by expressly so stating in writing. Any such written waiver by the City of a breach or violation of any provision of this Franchise shall not operate as or be construed to be a waiver of any subsequent breach or violation.
4. Rights Cumulative. All rights and remedies under this Franchise or retained by the City herein are not exclusive but are in addition to other rights and remedies available to the City. The exercise of remedies herein does not constitute the waiver of any other remedies.
5. Grantee Acknowledgment of Validity of Franchise. Grantee acknowledges that the terms and conditions of this Franchise are consistent with current law and are not unreasonable or arbitrary.

SECTION 13.

PUBLICATION EFFECTIVE DATE; ACCEPTANCE AND EXHIBITS

1. Acceptance. Grantee shall accept this Franchise within sixty (60) of its enactment by the City, unless the time for acceptance is extended by the City. Upon acceptance of this Franchise, Grantee shall be bound by all the terms and conditions contained herein. Grantee shall accept this Franchise by properly executing, acknowledging, and returning the Franchise to the City, and by delivering the performance bond and certificate of insurance required herein.
2. Publication: Effective Date. This Franchise shall be published in accordance with applicable local and Minnesota law. The Effective Date of this Franchise shall be the date of acceptance by Grantee.

EXHIBIT A
FCC CUSTOMER SERVICE REQUIREMENTS

LEASE AGREEMENT

This Lease Agreement (“Lease”) dated as of the ____ day of _____, 2012, by and between Bonnie Gathje (“Lessor”) and the City of Pine Island, a Minnesota municipal corporation (“Tenant”).

- 1. LEASED PREMISES.** The Lessor hereby leases and demises to Tenant the property and premises located at 611 North Main Street, Suite A, Pine Island, Minnesota, 55963 (“Leased Premises”). The Leased Premises are more fully described on Exhibit “A” attached hereto.
- 2. TERM.** In consideration of Tenant’s performance under this Lease, the Lessor hereby leases the Leased Premises for the period commencing on January 1, 2012 and expiring on December 31, 2012. The term of this Lease shall be renewed for additional one (1) year periods unless either party shall give written notice of non-renewal to the other party on or before November 1st.
- 3. RENT.** Tenant shall pay the Lessor rent in the amount of \$700 per month. Rent for the first month shall be due on or before February 1, 2012, and shall thereafter be due on or before the fifth (5th) day of each month.
- 4. USE RESTRICTIONS.** Tenant shall comply with all applicable laws, ordinances and governmental regulations, and shall not do anything in or about the Leased Premises which will impair or invalidate any policy of insurance required by this Lease.
- 5. ASSIGNMENT AND SUBLETTING.** Without further notice to or consent of the Lessor, Tenant may sublease the Leased Premises to the Goodhue County sheriff’s department for operation of a sheriff’s station and office. The Lessor may assign this Lease upon written notice to Tenant.
- 6. ENVIRONMENTAL.** Tenant agrees that throughout the term of the Lease, it shall not use the Leased Premises for the storage, handling, transportation or disposal of any Hazardous Substances, except as may occur in the normal course of operation of a Goodhue County sheriff’s station and office location.
- 7. UTILITIES AND OPERATING COSTS.** Lessor shall pay all charges for water, garbage and refuse removal, electricity, natural gas, and other utility services furnished to the Leased Premises, and all other costs associated with the use, operation and management of the Leased Premises provided, however, that Tenant or its sublessee shall contract for any desired telephone, internet or cable television services and shall be responsible for payment of all associated charges.
- 8. MAINTENANCE AND REPAIR OF THE LEASED PREMISES.** Tenant shall, at all times throughout the term of this Lease, and at its sole expense, clean, keep, repair and maintain the Leased Premises and fixtures in at least as good condition as existed on the date of this Lease, reasonable wear and tear excepted. Tenant shall not allow any liens or encumbrances to be placed on the Leased Premises.

9. ALTERATION OR IMPROVEMENT OF THE LEASED PREMISES. Tenant shall not make any additions or improvements in or to the Leased Premises without the Lessor's prior written consent.

10. INDEMNIFICATION. Tenant shall hold the Lessor harmless from and indemnify and defend the Lessor against any claim or liability arising in any manner from Tenant's use, improvement and occupancy of the Leased Premises, or relating to the death or bodily injury to any person or damage to any personal property present on or located in or upon the Leased Premises, including the person and personal property of Tenant's employees and all persons in or upon the Leased Premises at Tenant's invitation or sufferance. Nothing in this Lease shall be deemed to limit the Lessor's right to make applications to a governmental entity with respect to the Leased Premises, or to protest taxes or assessments related to the Leased Premises.

11. INSURANCE. Tenant or its sublessee shall carry insurance for the full insurable value of Tenant's supplies, materials, furnishings, vehicles, equipment and all other items of personal property of Tenant located on or within the Leased Premises. Additionally, Tenant or its sublessee shall keep in full force and effect a policy or policies of "occurrence" based commercial general liability insurance, providing coverage for bodily injury, personal property damage, personal injury, and contractual liability with combined policy limits in an amount not less than \$1,000,000. Tenant shall furnish evidence satisfactory to the Lessor at the time this Lease is executed that such coverage is in full force and effect.

12. WAIVER OF CLAIMS. Tenant hereby waives and releases all claims, liabilities and causes of action against the Lessor and its officials, agents, servants and employees for loss or damage to, or destruction of personal property of Tenant, located in, upon or about the Leased Premises resulting from fire, explosion or the other perils covered by standard "all risk" insurance.

13. QUIET ENJOYMENT. The Lessor warrants that it has full right to execute and to perform this Lease and to grant the estate demised, and that Tenant, upon Tenant's performance of all of the terms, conditions, covenants and agreements on Tenant's part to be observed and performed under this Lease, may peaceably and quietly enjoy the Leased Premises for the term of this Lease, subject to the terms and conditions herein.

14. SALE OR ENCUMBRANCE OF THE LEASED PREMISES. Subject to paragraph 5, if the Lessor sells or otherwise voluntarily conveys the Leased Premises during the term of this Lease, the purchaser of the property shall be required to accept assignment of this Lease and shall attorn to the rights of the Tenant.

15. HOLDING OVER. If Tenant remains in possession of the Leased Premises after the expiration or termination of this Lease, it shall be deemed to be occupying said Leased Premises as a Tenant at sufferance, subject to all the conditions, provisions and obligations of this Lease insofar as the same can be applicable to a tenancy at sufferance, including but not limited to the duty to pay rent.

16. SURRENDER. Upon expiration or termination of this Lease, Tenant shall peaceably surrender the Leased Premises and remove all debris and personal property from the Leased Premises. Tenant shall not remove any of the immovable fixtures. All debris and personal property may be disposed of by the Lessor. Tenant shall be responsible for any disposal costs.

17. ACCESS TO LEASED PREMISES. The Lessor and the authorized representatives of the Lessor shall have the right to enter the Leased Premises during usual business hours upon 24 hours' notice to Tenant or its sublessee, the Goodhue County Sheriff's department, provided, however, that the Goodhue County Sheriff's department may deny entry for any legitimate police operational, public safety or data privacy reason.

18. DEFAULT OF TENANT.

A. Events of Default: The occurrence of any one or more of the following events shall constitute an Event of Default:

(1) Tenant's failure to pay rent when due;

(2) Tenant's failure to maintain the insurance required pursuant to Sections 10 and 11 above, which failure remains uncured for 15 days following the Lessor's written notice to Tenant of Tenant's failure to perform such obligation; or

(3) Tenant's failure to fully perform any other Tenant obligations, which failure remains uncured for 30 days following the Lessor's written notice to Tenant; or

B. Lessor's Remedies: If an Event of Default occurs, the Lessor may terminate this Lease upon 30 days written notice to Tenant. Neither the passage of time after an Event of Default nor the Lessor's exercise of any other remedy with regard to such Event of Default shall limit the Lessor's right to terminate the Lease. The Lessor may also, whether or not the Lessor has elected to terminate this Lease, commence proceedings in Unlawful Detainer to recover possession of the Leased Premises. The Lessor shall be entitled to reimbursement of reasonable attorneys' fees which the Lessor incurs in connection with successfully pursuing any remedy for an Event of Default.

19. TERMINATION BY TENANT. Tenant may terminate this Lease upon 30 days written notice to Lessor in the event Tenant's contract with the Goodhue County Sheriff's Office is terminated and the Sheriff ceases to occupy the Leased Premises.

20. EMINENT DOMAIN. If an eminent domain or condemnation proceeding is commenced with respect to the Leased Premises during the term of this Lease, this Lease shall be terminable by either party upon written notice to the other. Damages in the event of any condemnation shall belong to the Lessor, except damages explicitly awarded as compensation for diminution in value of the leasehold of the Leased Premises, or as moving or relocation benefits.

21. DAMAGE OR DESTRUCTION. If fire or other casualty damages or destroys the Leased Premises or the Leased Premises incurs substantial damage due to vandalism, failure of building systems or other unforeseen cause occurs during the term of this Lease, then the Tenant shall have the option of either making repairs to the Leased Premises at his own expense so that it is in compliance with all laws and regulations or terminating the Lease. The Lessor shall have no obligation to effect any repairs to the Leased Premises.

22. GENERAL.

A. Lessor's Disclaimer of Warranty: The Lessor disclaims any warranty that the Leased Premises is suitable for Tenant's use.

B. Relationship of Landlord and Tenant: The Lease does not create the relationship of principal and agent or of partnership or of joint venture or of any association between the Lessor and Tenant, the sole relationships between the parties hereto being that of the Lessor and Tenant under this Lease.

C. Choice of Law: The laws of the State of Minnesota shall govern the validity, performance and enforcement of this Lease.

D. Notices and Demands. Except as otherwise expressly provided in this Lease, any notice, demand, or other communication under the Lease any related document by either party to the other shall be sufficiently given or delivered if it is dispatched by United States Mail or delivered personally to such addresses as the parties may, from time to time, designate in writing.

E. Entire Agreement and Amendment: This Lease constitutes the entire agreement between the Lessor and Tenant affecting the Leased Premises and there are no other agreements, either oral or written, between them other than said documents and as are herein set forth. No subsequent alteration, amendment, change or addition to this Lease shall be binding upon the Lessor or Tenant unless reduced to writing and executed in the same form and manner in which this Lease is executed.

F. Successors and Assigns: The terms, covenants and conditions of this Lease shall be binding upon and inure to the benefit of the successors and assigns of the parties hereto.

IN WITNESS WHEREOF, the Lessor and the Tenant have caused this Lease to be executed in form and manner sufficient to bind them at law, as of the day and year first above written.

3. Environmental:

- a. To encourage overall rate of recycling by residents and businesses.
- b. To improve the use of existing recycling facilities.

4. Planning Process:

- a. To engage all stake holders in the process and identify issues of importance to residents and businesses.
- b. Identify public and private priorities and come up with common goals.

5. Aesthetics:

- a. To reduce trash truck traffic and its associated noise.
- b. To provide more consistent and neater looking streets during collection days.

6. Hauler Impacts:

- a. To minimize displacement of trash haulers and encourage smaller and medium size haulers to provide services within the City.

NOTE: An updated set of goals and objectives will emerge after the planning process and after engaging the haulers and other stake holders.



VI. PUBLIC WORKS & ENGINEERING

A. 2012 Street Assessment Project Update

We are continuing with the development of the project plans and specifications for the project. The original design has been modified slightly based on the feedback we've received from the residents through the questionnaires received as well as from the informational meeting that was held last month. The biggest modification has included shifting 3rd Avenue 2 feet to the east and eliminating the sidewalk on the east side of 3rd Avenue. The street shift and the elimination of the walk will allow for more trees to be saved and will fit the field conditions better than the original design. The utility committee met to review and discuss the design modifications. There will be another public informational meeting held at City Hall at 5:30 prior to the council meeting on Tuesday.

The current schedule is to bring the plans and specification to the February meeting for your approval. If approved the project will be sent out to bid and bids will be received in March. Construction could then start in late April or early May.
